6. **Subject of the procurement:** service – 60112000-6 – public road transport services
7. **Description of procurement subject:** subject of the procurement no. 4/17 is service – public transport of passengers on the territory of the City of Belgrade (line cluster "500")

**8. Contract award criteria: economically most advantageous offer**

**Weighted elements of the criteria:**

- a. Price – 90 weights;
- b. Vehicle quality – 10 weights;
  1. Vehicle floor height – 7 weights;
  2. Ramp for access of persons with decreased mobility – 3 weights

**10. Submission of bids:** In accordance with tender documentation and this invitation. Bidders shall submit their bids directly to the Registry Office or by registered mail to City of Belgrade, City Administration of the City of Belgrade, Secretariat for Public Transport, 27. Marta street no. 43-45 – Registry Office, counter hall, 11000 Belgrade.

Bids are submitted in sealed envelope or box, in a way that during the opening it can be determined that it has not been opened before, stamped, with annotation – 'Bid – For the public procurement no. 4/17, Public transport of passengers on the territory of the City of Belgrade (line cluster "500") – **DO NOT OPEN**'. The name and address of the bidder, correct address, contact person and telephone must be stated at the back of the envelope or box. In case the bid submitted by group of bidders, at the back of the envelope it should be stated that bidders are acting as a consortium (group of bidders) and the names and addresses of all participants in the joint bid. The bid must be effective for 90 days since the opening.

It shall be deemed that bid is timely received if it is received by the procuring entity **21.08.2017. at 12 PM.**

**11. Opening of bids: 21.08.2017. at 12,30 PM** in Secretariat for Public Transport, 27. Marta street no. 43-45, Belgrade.

**12. Bidders' participation:** Opening of bids could be attended by all interested parties, but only representatives of bidders could actively participate. Special authorization, for participation in the opening, needs to be issued by the bidder in the original form, filed by the bidder, stamped and signed by the authorized representative of the bidder, and submitted to the president of the Public Procurement Committee immediately before opening of bids.

**13. Contract award:** 40 days since the opening of bids.
